- Evaluate synopses, treatments, screenplays and storyboards in accordance with dramaturgical and design features with a view to editing of picture and sound material
- · Classify, check and process sound, picture, animation and manuscript material for picture and sound editing
- Edit sound and picture material and create special image effects
- Prepare film for editing, carry out editing, select picture material on the basis of creative design also according due consideration to opportunities to use electronic tricks
- Prepare picture and sound materials for dubbing and editing of speech, sound effects and music to ensure synchronicity
- Evaluate picture and sound material with regard to creative design potential and technical quality
- Follow dramaturgical stipulations in designing audio-visual products using picture and sound material
- Work in close cooperation with directors and producers
- Comply with precise deadlines, particularly in the field of current affairs

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Film and video editors work in the film and television industry, such as for television companies, production companies or post-production companies.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
