The holder of this certificate:

- reads and makes preliminary studies, photographs the works to be restored
- has knowledge of the technology of the materials used for conservation and restoration, and selects the most suitable ones
- uses the most appropriate methods / ways of conservation and restoration
- uses laboratory tools and apparatuses
- does preventive conservation work and records conservation tasks on a special card
- performs specialised conservation work to various types of paintings (paper, textile, timber - fretwork, portable picture, mural, oil painting)
- performs specialised conservation tasks to works of art (ceramic, metal, organic materials, stone, mosaic, glass)
- has knowledge of the protective measures needed for the exhibition and storage of objects and works of art
- can use a computer
- takes all measures for personal protection and hygiene
- communicates in Greek and English, and comprehends technical manuals with English terminology.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE <sup>(1)</sup>

The holder of this certificate can work as a conservation employee in museums and painting exhibitions, and as a self-employed professional in private and public institutions that are holders of paintings.
